Samples

At least one current test sample is required to complete the test appliance/test adapter (hereinafter "Adapter"). If there is no current test sample available it may be necessary to carry out improvements to mechanical parts later. This will be charged separately. Scope of Delivery/Properties

The Adapter will be designed and produced exclusively in accordance with the test point and wiring lists, CAD files and test sample

provided to us by your company. Should this test sample not be complete or should it not have been available to us, no mechanical functional test can take place during the manufacture of the Adapter and no possible damage to the assemblies to be tested can be ascertained. We are not liable for malfunctions of our Adapter if we have not been sent a correct test sample prior to commencement of production.

The Adapter makes contact exclusively with the measuring points and contact points stipulated by your company and may only be used for testing the assembly for which the Adapter was produced.

Obligations to Co-operate/Performance not Included

We would expressly point out that your test sample cannot provide any information regarding the actual series production and accordingly cannot serve as a reference for subsequent series production. Following commissioning of our Adapter you must therefore check a sufficient and appropriate number of assemblies for any damage to the said assemblies employing suitable measures and check the accuracy of the test result before you use this Adapter for testing in series production.

A complete test system is only fully functional once the Adapter has been integrated into an electronic test system with the corresponding test software. Neither the test system nor the test program was made available to us during production of the Adapter. Therefore we cannot test the ability of the Adapter to perform in advance. The implementation of the Adapter in the test system is not part of the scope of our service and must be secured by you.

We are sure you will understand that we cannot accept liability for correct test performance as any such responsibility stems from the construction design of your assembly and the deviations in serial production.
